## Physicians Plead for Streamlined Systems During Energy & Commerce Subcommittee Hearing on MACRA Implementation

House E&C Subcommittee on Health: Medicare Access and Chip Reauthorization Act of 2015 (MACRA), Examining Physician Efforts to Prepare for Medicare Payment Reforms

Advocates	Stance
American Medical Association	Asked CMS to consolidate performance reporting, broaden APMs, and improve measurement to reflect differences between medical practices. Physicians need room for trial and error to determine what will work for patients.
American College of Physicians	Applauded MACRA, and stated that the program would combat physician burnout. They also advocate for easier reporting to CMS.
American Academy of Family Physicians	Launched a multiyear educational program on MACRA for its members. Advocating to delay the performance year to 2018, which will set the threshold for physician reimbursement in 2019.

## Physicians Advocates' Main concerns:

- There is neither a robust nor interoperable Electronic Health Recording system implemented
- No options for treating patients beyond face-to-face meetings.
- The new regulations need to be flexible, as there are many models of practice.

## What's Next:

- CMS will release the final Quality Measure Development Plan on May 2, 2016
- MIPS goes into effect in 2017. The performance year will determine how MIPS scores will be implemented and have an effect on payment adjustments, which start in 2019.
