

United Health Group Dominates Market Share in Health Insurance


Net Sales and Market Value of Top Six Health Insurance Companies, in Billions

United Healthcare 2013-2015 Operation Earnings and Expected Earnings, in billions USD




Exit of ACA Health Exchanges

Anthem 2013 - 2015 Operating Income, in billions USD




Anthem Financials in 2015
