ТРР	Against	While initially supporting it, Ross noted that there were several aspects of TPP which he disagreed with
Additional tax credits	Supports	Ross supports providing businesses with additional tax credits because he believes it is the best method of stimulating the infrastructure market
Anti-dumping steel measures	Supports	Ross believes that anti-dumping steel measures towards China should be implemented

Ross is a billionaire investor known in financial circles as "the king of bankruptcy" for his success in building new companies from the assets of defaulted ones. Rothschild entered the finance world in 1976 as a bankruptcy advisor for Rothschild Inc. Ross has been a long-time Trump ally, having him helped bail out his casino companies in the early 1990s. A former Democrat, Ross was an adamant supporter of Trump from the beginning of his campaign and went to serve as one of his main economic advisors.
