## The White House:

- **Monday**, the president will chair a **cabinet meeting** before hosting the **2016 NCAA Football National Champion** Clemson Tigers
- **In the afternoon**, the AGs of Maryland and DC are to announce a **lawsuit against President Trump’s** receiving money from foreign governments
- **Tuesday**, Trump will travel to **Wisconsin** Ivanka to meet with Gov. Scott Walker and present on apprenticeship and job development programs
- **Wednesday**, Trump will present a “major policy speech” at the **Department of Labor** and Ivanka will hold a roundtable with 15 CEOs
- **Thursday**, Trump will host a **roundtable of 8 governors** from states with “successful workforce development programs”
- **Friday**, Trump will travel to **Miami** to discuss changes to the United States’ stance towards **Cuba**
