Takeaways from POLITICO-Harvard's July 2017 voter poll



Most voters oppose the tax code overhaul

President Trump's proposed federal income tax cuts — which would involving reducing rates and eliminating tax breaks for the wealthy and "special interests" — are favored by just 24% of the public, and opposed by 62%, including Republicans.



Democrats strongly oppose Trump's tax plan; Republicans are split

40% of Republicans favor Trump's tax code overhaul, and 41% oppose it; however, 62% believe it would help the economy. 85% of Democrats and 60% of independents are against Trump's tax plan.



Republicans dislike current ACA replacement

Only 20% of Republicans said they'd support a plan subsidizing health coverage for a lot fewer people; 42% would support a plan subsidizing health coverage for "somewhat fewer people." Only 1 in 3 Republicans would accept insurers charging people with preexisting medical conditions more for insurance.



Most respondents disapproved of withdrawal from Paris climate treaty

53% of respondents disapproved, but opinions were split along party lines – 91% of Democrats opposed it, and 65% of Republicans favored it.



Some issues hold more weight with voters


Trump's counterterrorism efforts were ranked as extremely important for 39% of voters; his ACA replacement effort ranked as extremely important for 37%; and his proposed budget ranked as extremely important for 34%. The poll results may indicate that, despite the highly politicized debate about the ACA, other, broader issues may play a central role in settling the 2018 congressional elections.


Which issues do voters consider extremely important in the 2018 congressional elections?

Percentage of voters – intending to vote for either Democratic or Republican candidates – saying each issue is extremely important in the 2018 congressional elections




What do voters think of Trump's economic policies?

Attitudes toward President Trump's tax cut proposal




Notable trends


- · While 56% of Republicans believe Trump's policies have helped the economy, 57% of Democrats say they have hurt it
- The majority (62%) of the general public opposes the president's current tax proposals, and only about one in four (24%) support them. Only 40% of Republicans are in favor, while 41% are opposed

Views on whether Trump's tax cut proposal would help or hurt them




Notable trends


- Although a narrow majority of Republicans do not support Trump's tax proposals (see slide 4), the majority (62%) still believe the proposal will help the economy. Democrats, meanwhile, overwhelmingly (85%) think these tax proposals will not improve the U.S. economy
- · 35% of Republicans believe Trump's tax cut proposal would help them; only 7% of Democrats say the same

Views on the effort the U.S. should put into working with other countries to address climate change in the future




- The majority (53%) of the American public disapproves of the president's decision to exit the Paris climate change agreement, while 30% approve
- · However, opinion is divided by party: the majority of Republicans (65%) approve of Trump's decision, and the majority of Democrats (81%) disapprove

Notable trends

- · More report being helped by the law than hurt, but the majority of Republicans and Democrats believe that the law has not impacted them directly
- All groups oppose a policy that would charge those with pre-existing medical conditions more for health insurance; thus, the core of much of the House and Senate repeal and replace bills remains unpopular with the general public
