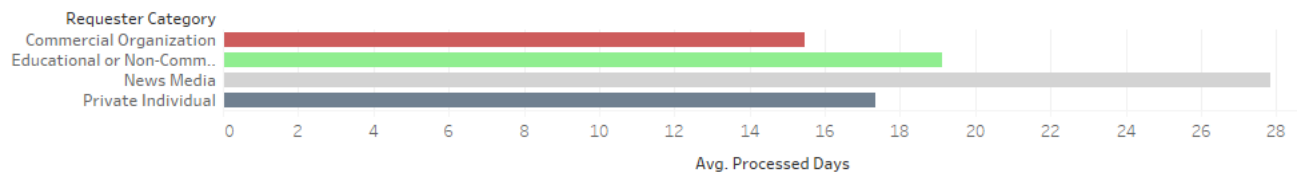

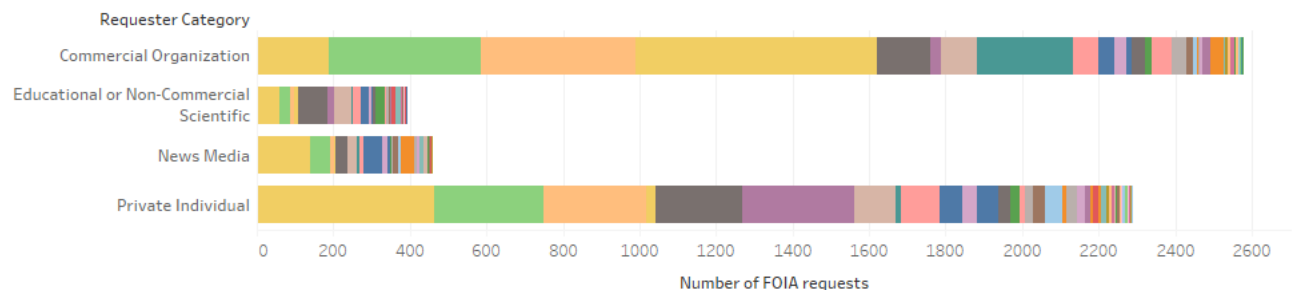

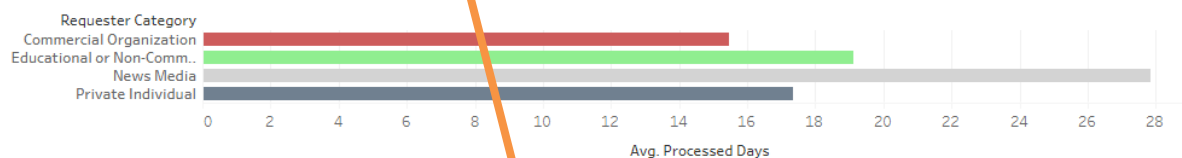

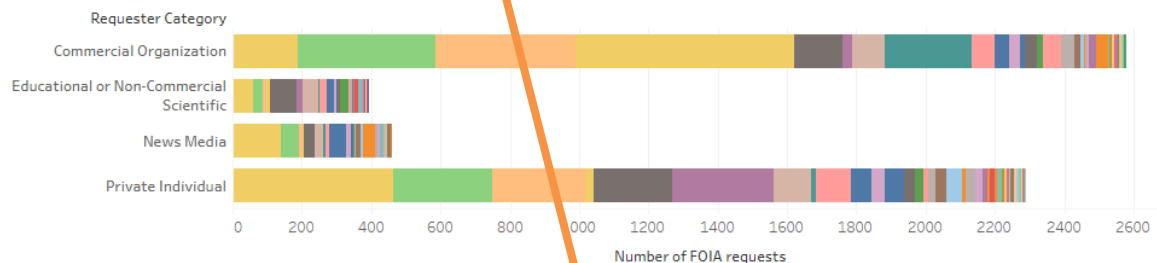

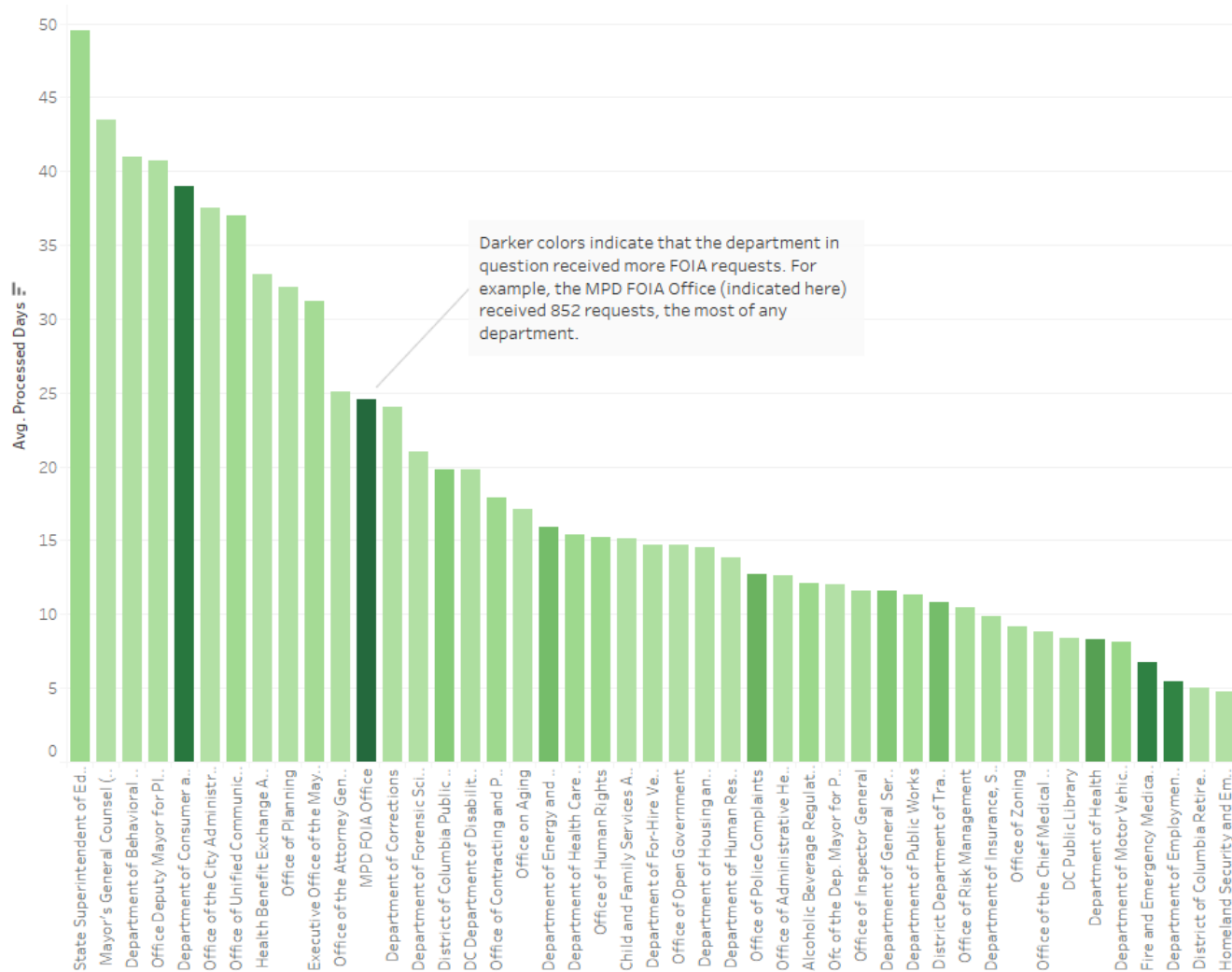

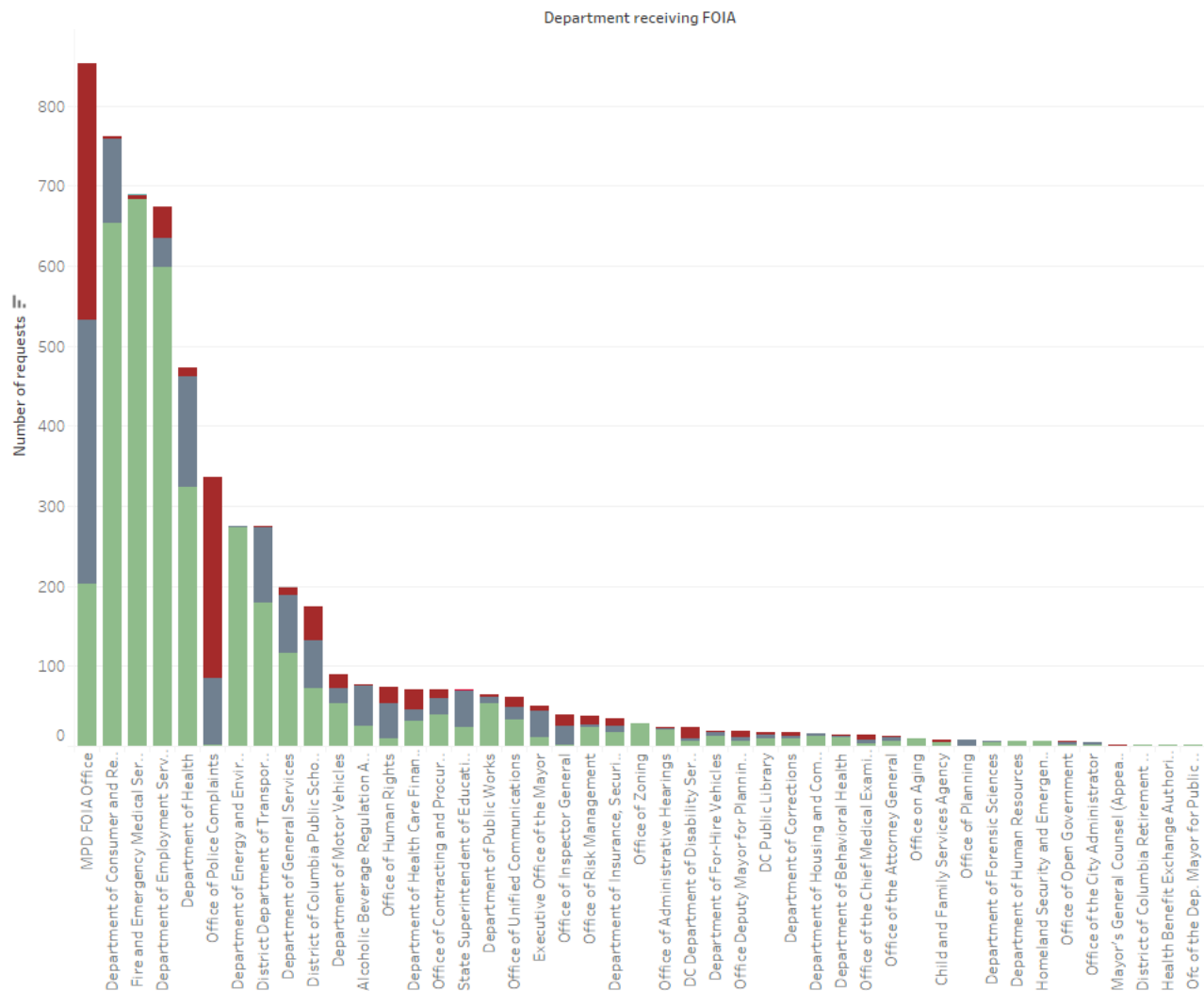

How long it takes each department to process a FOIA request



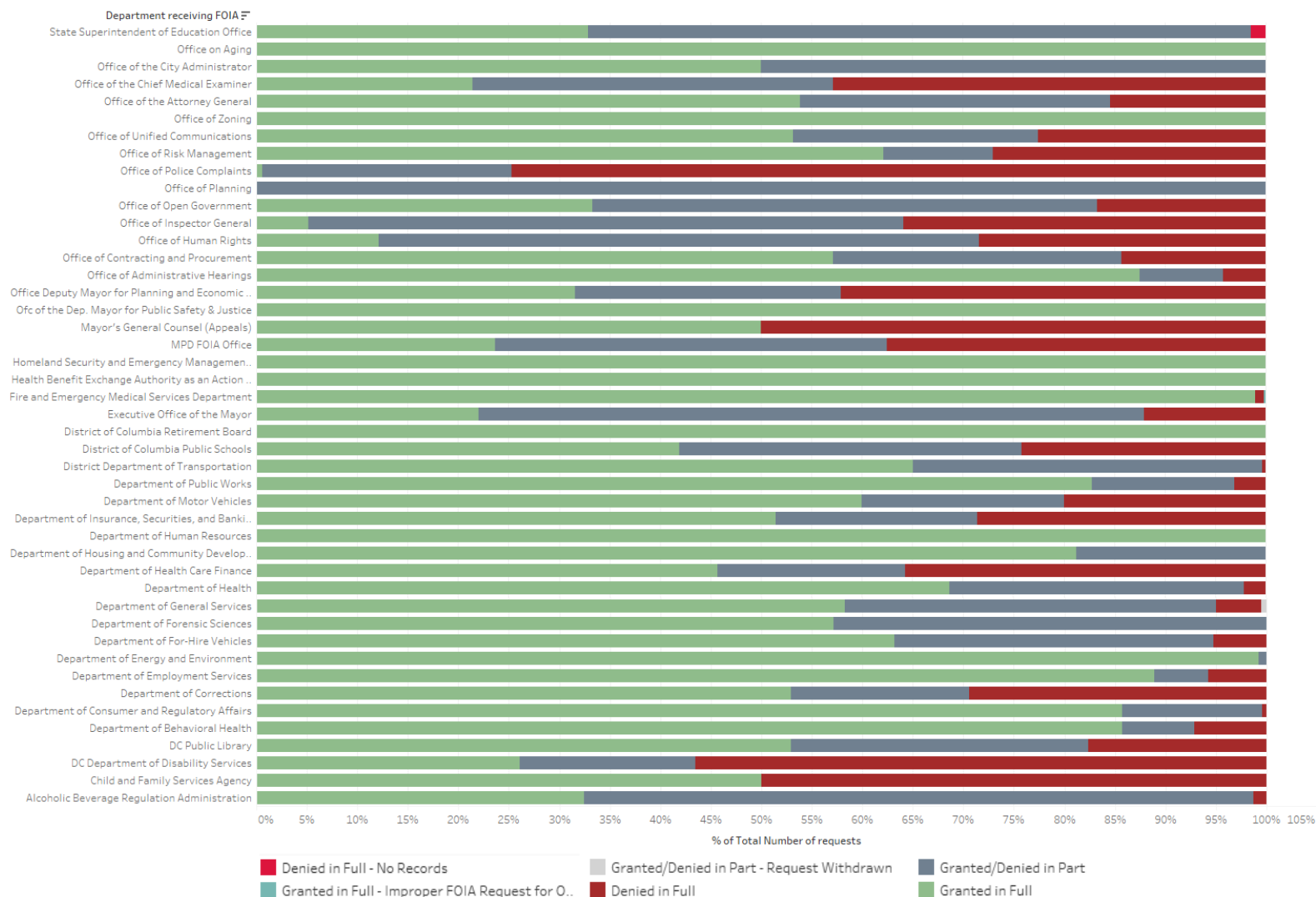
