Kim Guadagno

- Running mate: Carlos Rendo
- Currently: New Jersey's lieutenant governor under Chris Christie, serves a dual role as New Jersey secretary of state
- Previously: Monmouth Country sheriff
- Won the Republican primary with 46.82% of the vote

Key policy issues



Guadagno believes the pension crisis has become a "ticking time bomb" and threatens to force draconian spending cuts, massive tax hikes or collapse the retirement system if New Jersey ignores the problem. She promised to honor pension commitments to current retirees and bring public health insurance plans in line with private sector offerings.



One of the main campaign issues for Guadagno and the election at large is that of high property taxes. Guadagno promised to cut property taxes to prevent New Jersey residents from moving to cheaper states like Pennsylvania, North Carolina and Texas.



She has also stressed that military and veterans affairs will be among her top priorities as a military mother herself. Her main goals are to promote opportunity for veterans, reduce veteran homelessness and suicide rates, and strengthen the military economy.

- Endorsed and fundraised for Hillary Clinton in the 2016 presidential election
- · Announced candidacy May 2016

Key policy issues



Murphy plans to create a public bank where people can invest their money in an institution that benefits the state of New Jersey instead of Wall Street. The public bank would make "critical investments in our state and its people."



Murphy is campaigning on a platform of expanding access to both early education and higher education. He plans to re-invest in New Jersey's institutions of higher education and community colleges to make them affordable as well as expand K-12 STEM-oriented curriculum.



Another of Murphy's ideas is to convene an Innovation Cabinet, bringing together people from inside and outside government to work toward a common goal of getting state government to be more "customer friendly."









New Jersey's fastest growing county, Gloucester, is among counties to watch on election night


Outlook for New Jersey's 2017 gubernatorial election, by county

Compares results from 2012 presidential, 2013 gubernatorial, 2014 senatorial and 2016 presidential elections

- Safe Republican Voted Republican in all 4 elections
- Lean Republican Voted Republican in at least 2 recent elections
- Swing County
- Lean Democratic Voted Democratic in at least 2 recent elections
- Safe Democratic Voted Democratic in all 4 elections

Analysis

- Somerset County (1) has swung back and forth over the past four elections. The county voted for Gov. Chris Christie (R) by a margin of 30 points in 2013 but in the following year, Sen. Cory Booker (D) lost it by only 1 point. For presidential elections, the county voted for Democrats in both 2012 and 2016.
- Som erset County is largely suburban and has previously ranked among the top-10 wealthiest counties in the United States.
- Gloucester County (2) is an Obama-Trump county. The last time the county voted for a Republican presidential nominee before Trump was 1988.
- Gloucester (2) is located directly south of Philadelphia and was the fastest growing county in the state when comparing 2000 and 2010 census data.
- Republican candidate Kim Guadagno has criticized both Pres. Donald Trumpand Gov. Chris Christie on the campaign trail. While the national Republican Party has begun moving a way from courting wealthy suburban voters in fav or of the white working class, it appears as though Guadagno is committed to continued support of a reas similar to both Gloucester and Som erset.



Voters point to property taxes as their top issue


July 2017 poll: voter preferences for the most important one or two issues facing the state of New Jersey right now



^{*}Under the matching funds program -New Jersey allows gubernatorial candidates to receive \$2 in public money for every qualifying dollar they raise. The candidates must raise at least \$430,000 to qualify, are eligible for up to \$9.3 million in public funds, and are limited to spending \$13.8 million in the general election.




Both major candidates rely heavily on large donations
