Department of Veterans Affairs

Overview

The United States Department of Veterans Affairs (VA) is a cabinet-level federal department responsible for coordinating and administrating benefits programs for military veterans and their families. The department has three main divisions: the Veterans Health Administration, which provides medical services through hospitals and other facilities; the Veterans Benefit Administration, which provides other non-medical benefits such as loan-guarantees and educational funds; and the National Cemetery Administration, which oversees veterans cemeteries and memorial services.

Mission

To fulfill President Lincoln's promise "To care for him who shall have borne the battle, and for his widow, and his orphan" by serving and honoring the men and women who are America's veterans.

History

National assistance programs for veterans have existed since the Revolutionary War, but the VA's modern organization has its foundation in the post-World War I era, when the number of veterans returning from war rapidly grew. The GI Bill, first signed by FDR in 1944 and modified over the years, provides occupational, financial and educational benefits to veterans. President Reagan promoted the VA to cabinet-level status in 1988, and the department currently runs 152 hospitals, 800 community clinics, 126 nursing homes, and 35 domiciliaries.

Important Legislation

The Department of Veterans Affairs administers many benefit programs authorized by Congress.

Some of the main laws that authorize VA programs are:

- •The Servicemen's Readjustment Act of 1944 (Original G.I. Bill)
- •The Montgomery G.I. Bill of 1984
- •The Post-9/11 Veterans Educational Assistant Act of 2008 (Post-9/11 G.I. Bill)
- •The Veterans Access, Choice and Accountability Act of 2014

Additionally, the department is authorized to modify its programs for the proper functioning of its loan-guarantee and educational assistance programs, as well as its many hospitals and clinics.

"Day one" issues for the new administration

Wait times

Scandal struck the Obama administration in 2014 when it was reported that many veterans were dying while waiting long periods of time to see a doctor. Obama signed legislation in 2014 that provided funding for veterans to see non-VA physicians if a VA facility was not within 40 miles of the veteran's residence.




Privatization

Trump has pledged to allow veterans to seek treatment at a facility of their choosing, whether it is VA-run or private, but his pick for secretary of the VA has openly opposed "privatization" of the VA.

Biography

Dr. Shulkin currently serves as the under secretary of health, the chief executive of all the VA's hospitals, clinics and other medical facilities. He was appointed to the Senate-confirmed position by Obama in 2015. Shulkin has an extensive background as a hospital administrator as well as a practicing physician. He previously was president and CEO of Beth Israel Medical Center in New York City, chief medical officer of the University of Pennsylvania Health System and president of the Atlantic Health System Accountable Care Organization, among other positions. He received his medical degree from the Medical College of Pennsylvania (now a part of Drexel University) and completed his residency at the University of Pittsburgh Presbyterian Medical Center. In the Senate hearing for his nomination to VA secretary, he promised major reforms to the VA, with improved access and expanded care options. He also noted that he opposed President Trump's preference for privatizing parts of the VA.




