## Mission to the UN

### **Overview**

The U.S. Mission to the United Nations (USUN) serves as the United States' delegation to the United Nations. USUN is responsible for carrying out the nation's participation in the world body.

### Mission

The United Nations is an international body that aims to maintain peace and security, protect human rights, deliver humanitarian aid, promote sustainable development and uphold international law. USUN represents the United States at the United Nations.

### History

In the aftermath of World War II, the UN was formed in an effort to establish lasting peace. In 1947 the United States Mission was created by an act of Congress to assist the President and the Department of State in conducting United States policy at the United Nations. Since that time, USUN has served a vital role as the Department of State's UN branch.

## New stance on Israel

Nikki Haley, the new US ambassador to the UN, said "Nowhere has the UN's failure been more consistent and more outrageous than in its bias against our close ally Israel." The Obama administration allowed the UN to pass a resolution condemning Israeli settlements; the Trump administration staunchly opposes this decision and may withhold funding to the UN until the resolution is overturned.

## **Continue sanctions on Russia**


With Trump expressing admiration and approval of Russian Prime Minister Vladimir Putin throughout the campaign, many wondered if his administration would end sanctions against the nation. However, in her first appearance at the UN Security Council, Nikki Haley indicated that the sanctions would remain so long as Russia continued to occupy Crimea.



## Nikki Haley

Position: Ambassador to the UN

#### Biography

In 2004, Haley decided to challenge Republican state Rep. Larry Koon, who had been in office since 1975. She won that matchup to become the first Indian-American Republican state legislator in the United States. She won reelection in 2006 and 2008 with ease. In 2009, Haley ran for governor of South Carolina and won with 49% of the vote. Since becoming governor, has become popular and well known outside of the state. She endorsed former Mitt Romney in the hotly contested 2012 South Carolina Republican presidential primary. The spotlight turned back on her state in the wake of the Charleston church shooting in 2015 and she was praised for her success in uniting citizens in its aftermath. Paul Ryan has cited Nikki Haley as an "inclusive leader" with a "path for the future" as she represents a fresh, diverse face for Republicans while pushing a policy agenda in line with the traditional establishment.


