Quick Summary

Highly popular Republican governor in a blue state who juxtaposes pro-business, anti-tax message with across-the-aisle work on climate and infrastructure

- Son of a U.S. Congressman and native Marylander with early interest in politics
- Founded a real estate business; frustration with state tax environment spurred him to create Change Maryland, an anti-tax advocacy non-profit, which fueled his gubernatorial campaign
- Focused time in office on providing financial relief to the state taxpayers, including through tax breaks, lowering toll prices, and removing regulations that hinder business
- Champions Chesapeake Bay restoration and has joined national coalitions to address climate change
- Pursues public-private partnerships to fund state infrastructure such as the Purple Line expansion
- Well respected in his state and amongst fellow governors; second Republican governor in the state's history to be re-elected and was unanimously elected by his peers to chair the National Governors Association

Approach and Motivations

Results-oriented Republican whose moderate stances help him achieve bipartisan goals

- Says he seeks the best solutions, regardless of the side of the political aisle they come from
- Considers his father his biggest political inspiration, citing Hogan Sr.'s dedication to bipartisanship; Hogan Sr. was the first Republican to vote for President Nixon's



impeachment, and the only Republican to vote for all three articles of impeachment

- In his capacity as chair of the National Governors Association, he has worked with Democratic state leaders on national infrastructure policies; active member in bipartisan U.S. Climate Alliance
- Has given mixed messages on President Trump, balancing strong criticism with praise on economic matters; supported the House impeachment inquiry

Policy Position and Areas of Focus

Prioritizes growing economy, infrastructure, and protecting the environment

Economic Growth: Fostering a strong economy through tax breaks and deregulation

- Prioritizes tax relief, including through breaks for families, small businesses, and retirees; signed bill to repeal stormwater remediation taxes
- Announced cost reductions at all major toll facilities to save taxpayer money
- Focused on deregulating rules for businesses; created Regulatory Reform Commission, eliminating or reforming 850 regulations, including continuing education requirements for professional licensing

Infrastructure: Extends and modernizes transportation infrastructure through public-private partnerships

• Under his leadership, MDOT broke ground on the Purple Line light rail public-private partnership to extend metro lines from Bethesda to New Carrollton

- Introduced Traffic Relief Plan to widen the Capital Beltway, I-270, and the Baltimore-Washington Parkway through America's largest transportation public-private partnership
- As chair of the National Governors Association, launched Foundation for Success initiative to rebuild and repair infrastructure in ways that will grow the economy

Climate: Active in regional and national climate frameworks; mixed record on fracking

- Chairs the six-state Chesapeake Executive Council, which leads the restoration of the Chesapeake Bay; established the Governor's Task Force on Renewable Energy Development and Siting to grow state solar and wind projects
- Opposed the U.S. exit from the Paris Agreement; joined bipartisan coalition of states in the U.S. Climate Alliance to uphold the commitments of the Paris Agreement
- Signed law banning fracking in the state but supported pipelines in Maryland that transport out-of-state natural gas obtained by fracking

Core Communities

Bipartisan network of governors and state bureaucrats; active in business community

Governors: Collaborates with bipartisan gubernatorial allies, especially on infrastructure and climate

- Worked as Secretary of Appointments in the administration of Governor Bob Ehrlich (R) before entering politics
- Chair the National Governors Association alongside Vice Chair Andrew Cuomo (D), where he has focused on issues of infrastructure
- Member of bipartisan coalitions of governors that address climate change, including the U.S.





Climate Alliance, American Flood Coalition, and Chesapeake Executive Council

Pro-Business Community: Longstanding ties to state business arena; involves business community in policy process

- Founded a successful real estate company now run by brother Timothy Hogan
- Founder of Change Maryland, a nonprofit antitax advocacy organization, which he used to promote his own 2014 gubernatorial campaign; co-founder Thomas Kelso is President of Matrix Capital Markets Group
- Named Maryland business executives including business law attorney Abba David Poliakoff and Soltesz CEO Jim Soltesz to his Regulatory Reform Commission

Maryland Bureaucrats: Personal bipartisan relationships in state government

- Familial ties to state government including father Lawrence Hogan Sr., who served as a U.S. Congressman and as Prince George's County Executive; brother Patrick N. Hogan was a representative in the Maryland House
- Tapped friend and former Maryland Secretary of General Services Boyd Rutherford as his gubernatorial running mate
- Fostered close ties with powerful state Democrats, including former Governor and mentor and friend Marvin Mandel and former President of the Maryland Senate Mike Miller

- Born in Washington, D.C. and grew up in Landover, Maryland
- Moved to Florida with his mother after his parents divorced
- While in college, worked in the Florida State Legislature and then on Capitol Hill
- Helped his father run a successful campaign for Prince George's County Executive and later worked for his father as a legislative liaison

Wife Yuki is a first-generation Korean American



- Yuki Hogan works as an artist and teacher at the Maryland Institute College of Art
- She is the first Asian first lady in Maryland history and the first Korean-American first lady in U.S. history
- They have three daughters, four grandchildren, and two shih tzu dogs

Cancer survivor

- Diagnosed in 2015 with stage three non-Hodgkin lymphoma
- Completed 18 weeks of chemotherapy and announced the cancer was in remission
- Underwent his final chemotherapy treatment in 2016 and was deemed to be cancer-free

Criticisms and Controversies

No notable controversies
